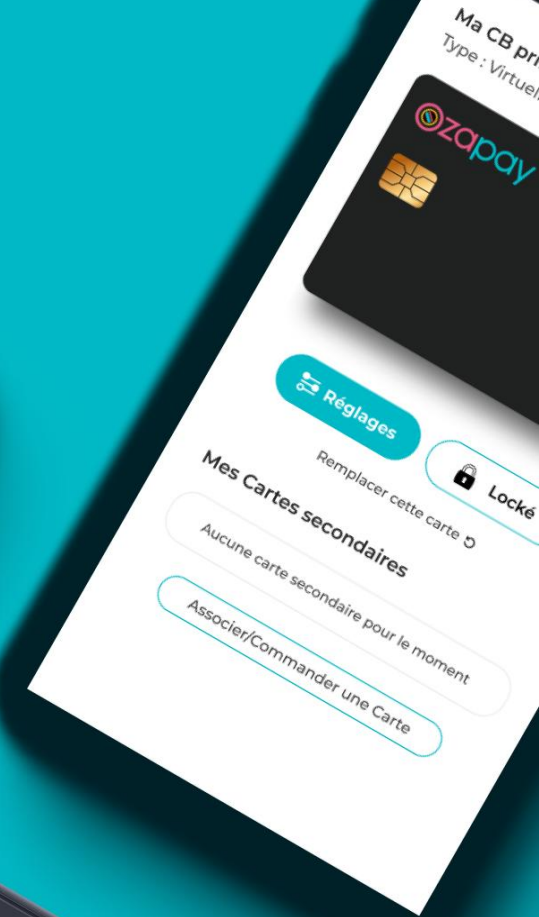
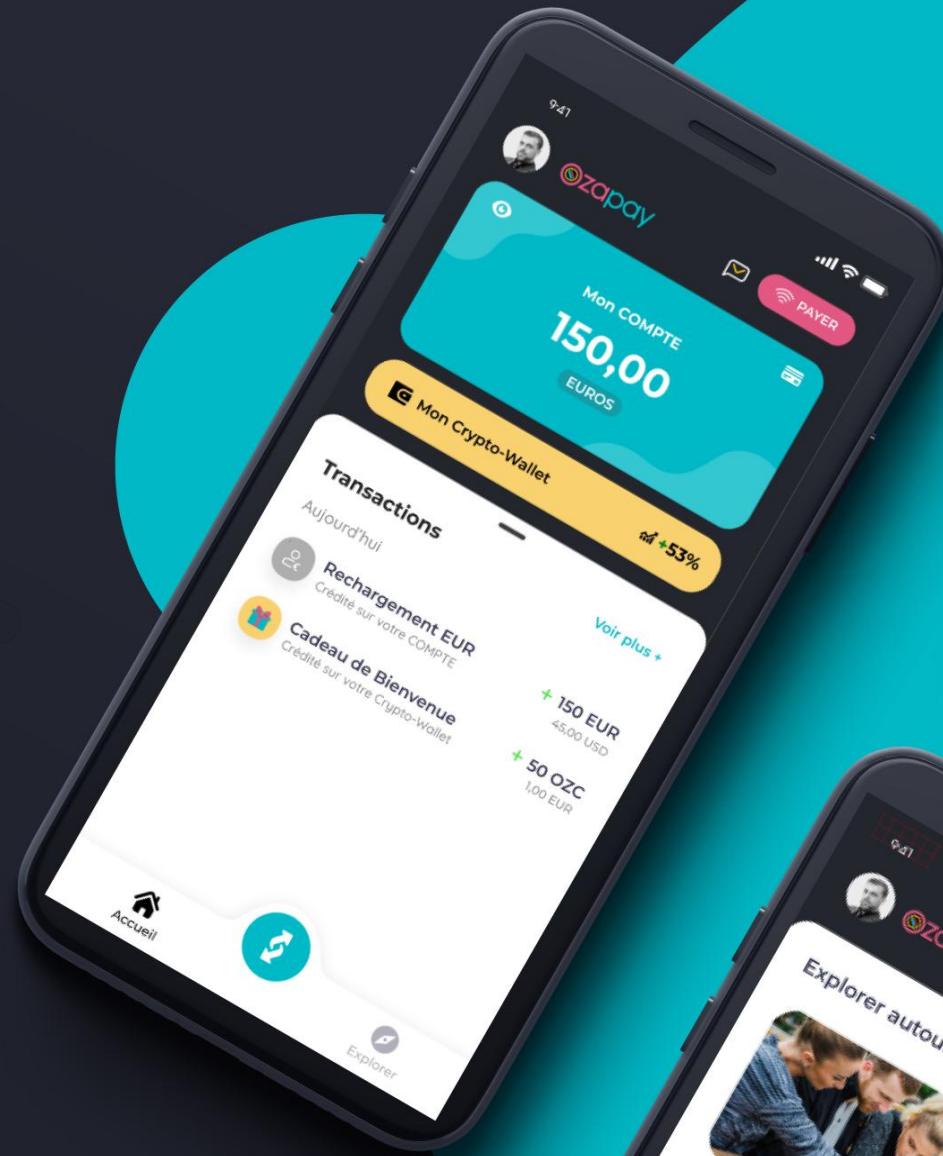

A Community including a **News Feed** and **Messaging!**

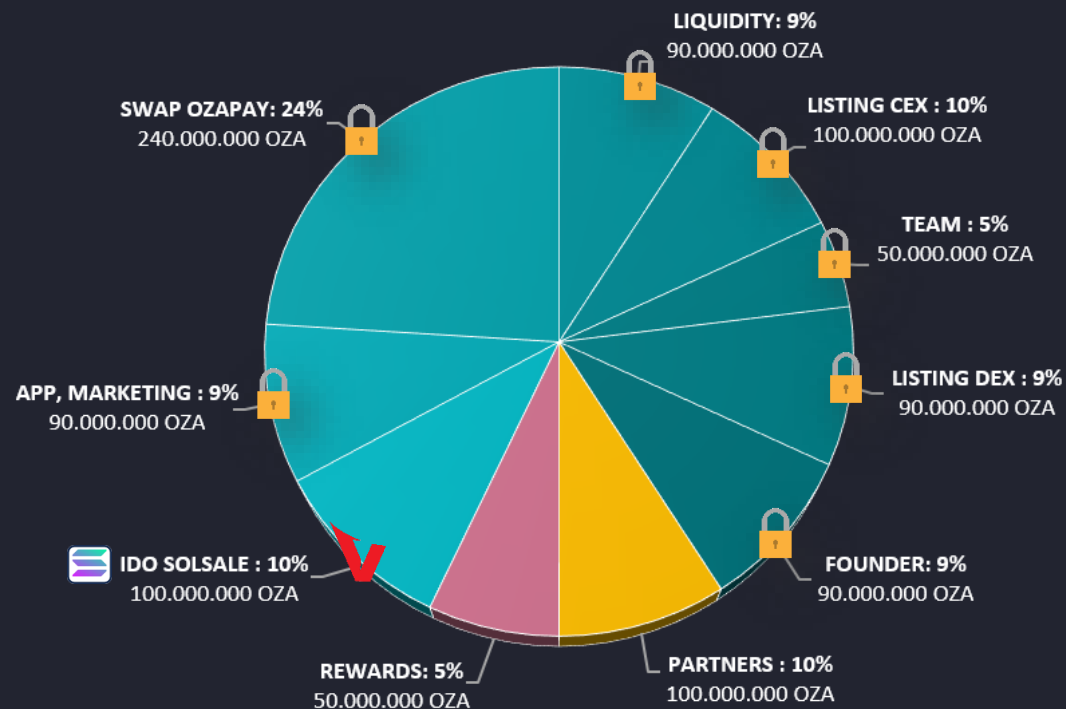
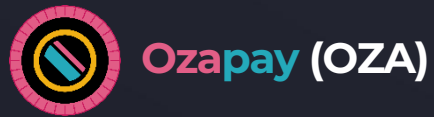


Presentation of the brand token OZA

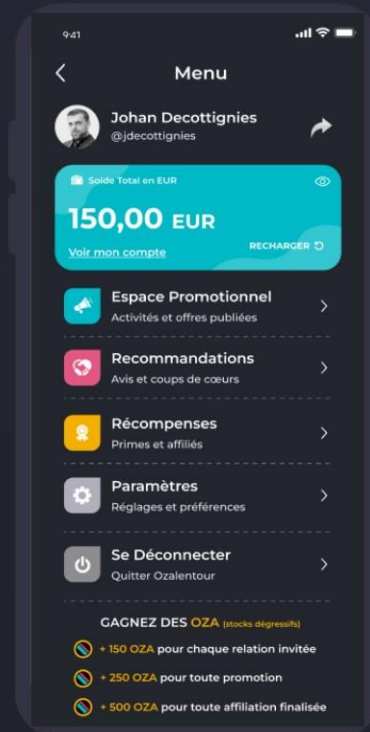
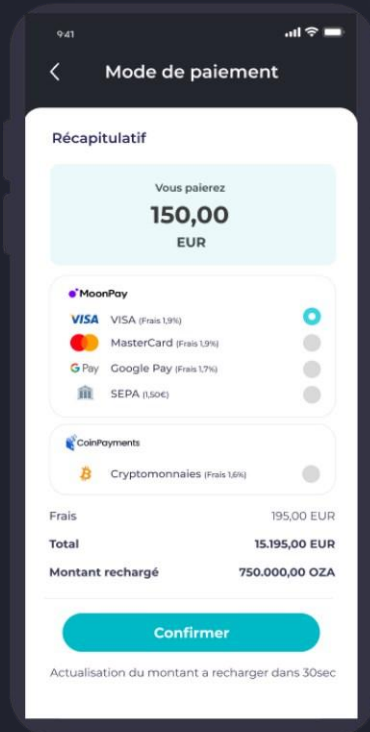
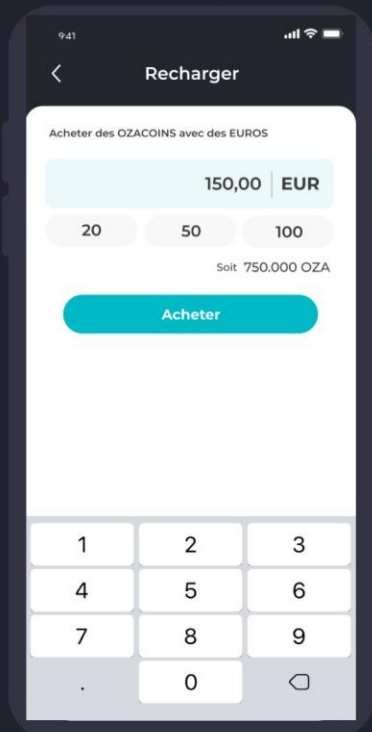
How the OZAPAY account works

PSAN regulation: LinkCy SAS, PSAN agent, registered in France under identifier E2023-73 (AMF).

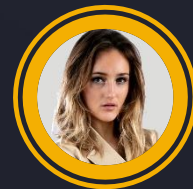
