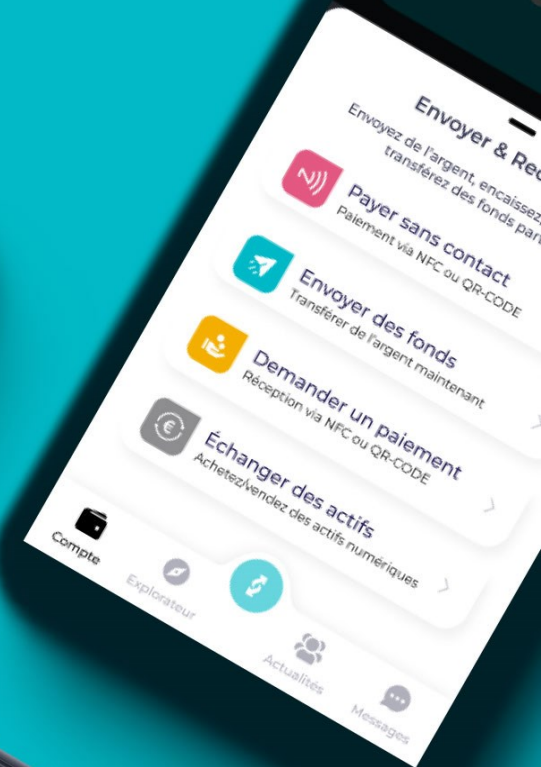
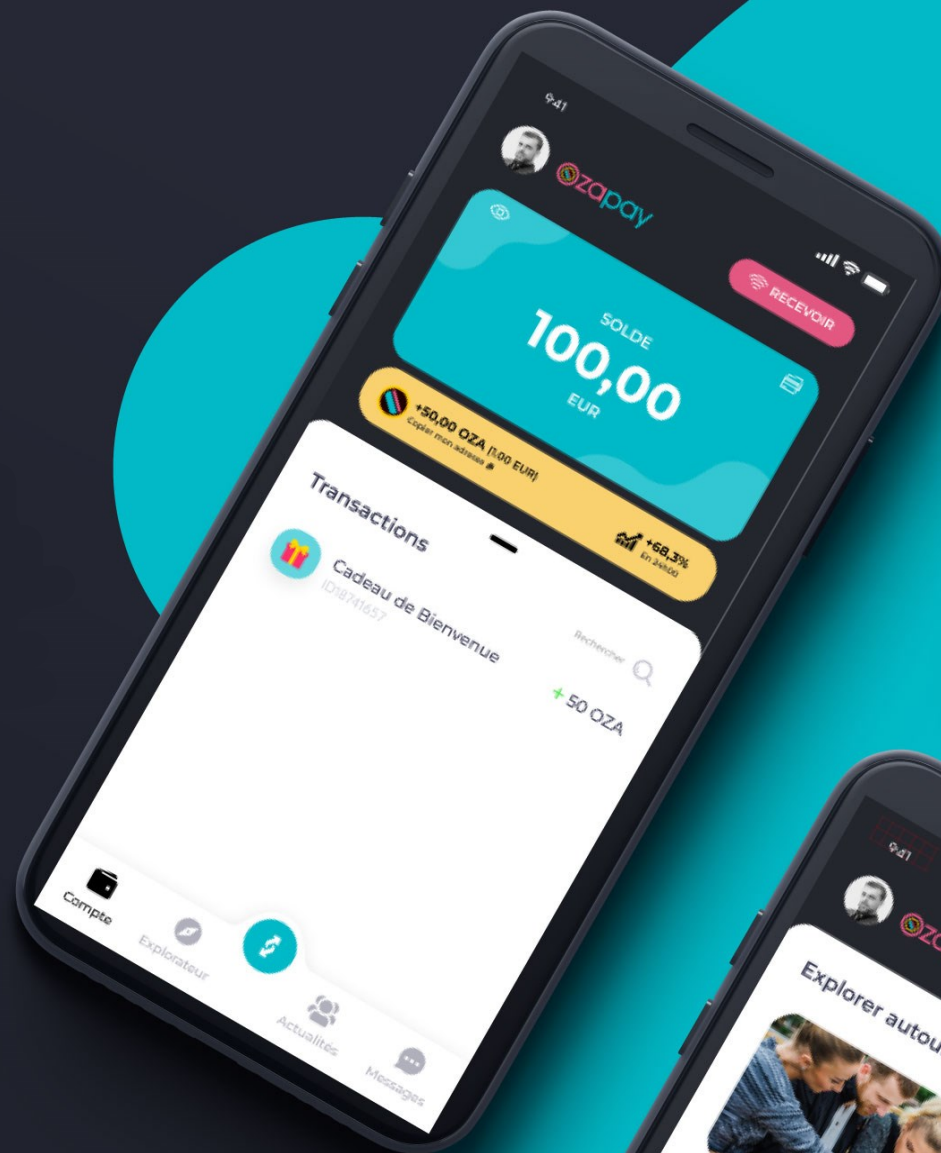

A Community including a News Feed and Messaging!



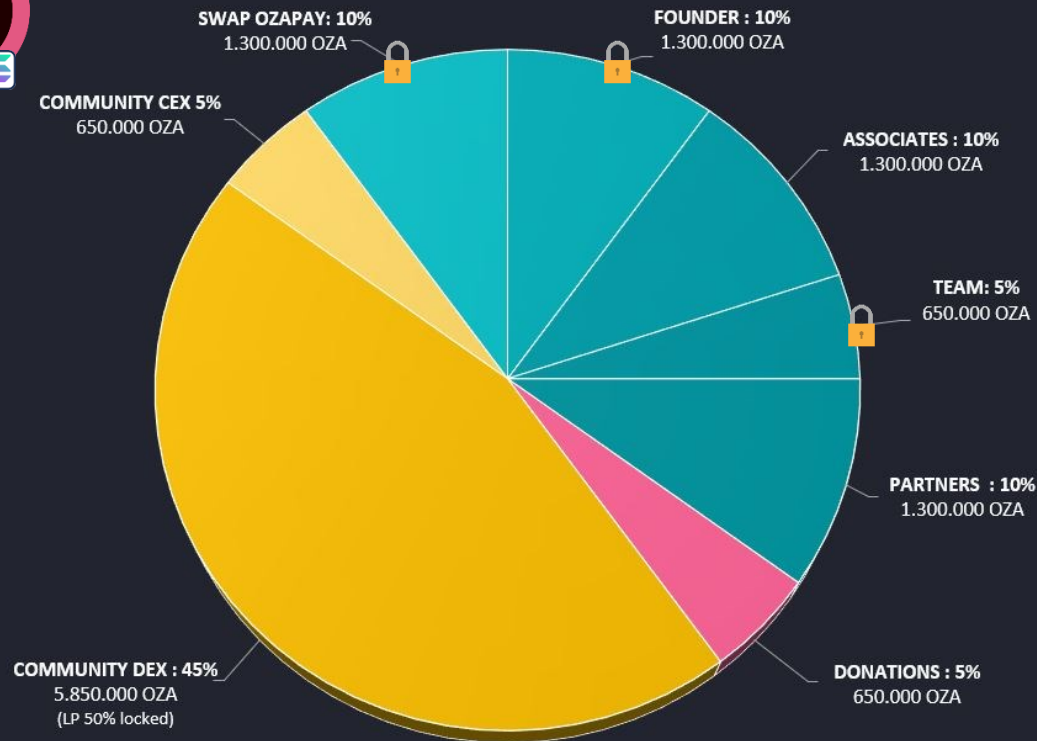
Introducing the OZAPAY (OZA) token



Our **OZAPAY (OZA)** utility token is designed to enhance our brand and our payment application. **OZA** also facilitates transactions, exchanges and conversions in all currencies via our future app, various **centralized (CEX) and decentralized (DEX) markets**.

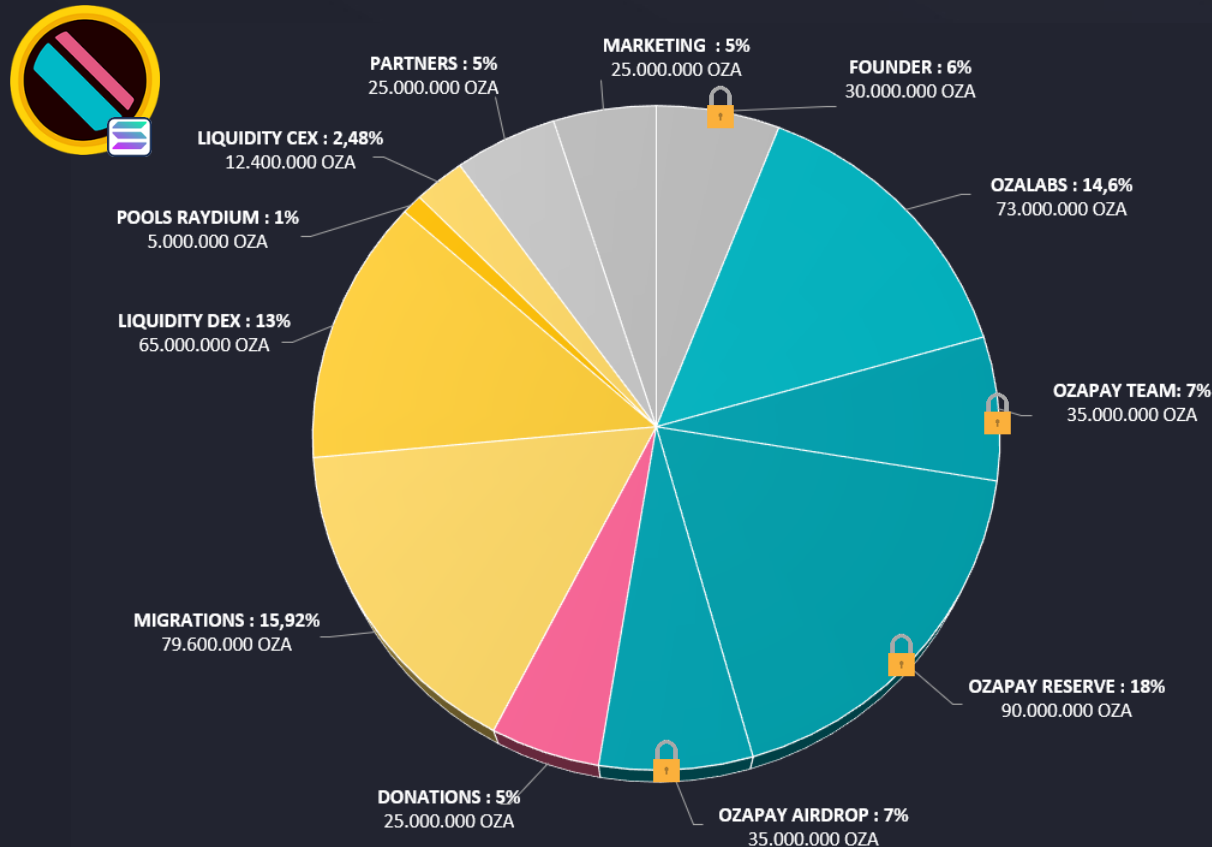
Introducing the OZACOIN token (OZC)

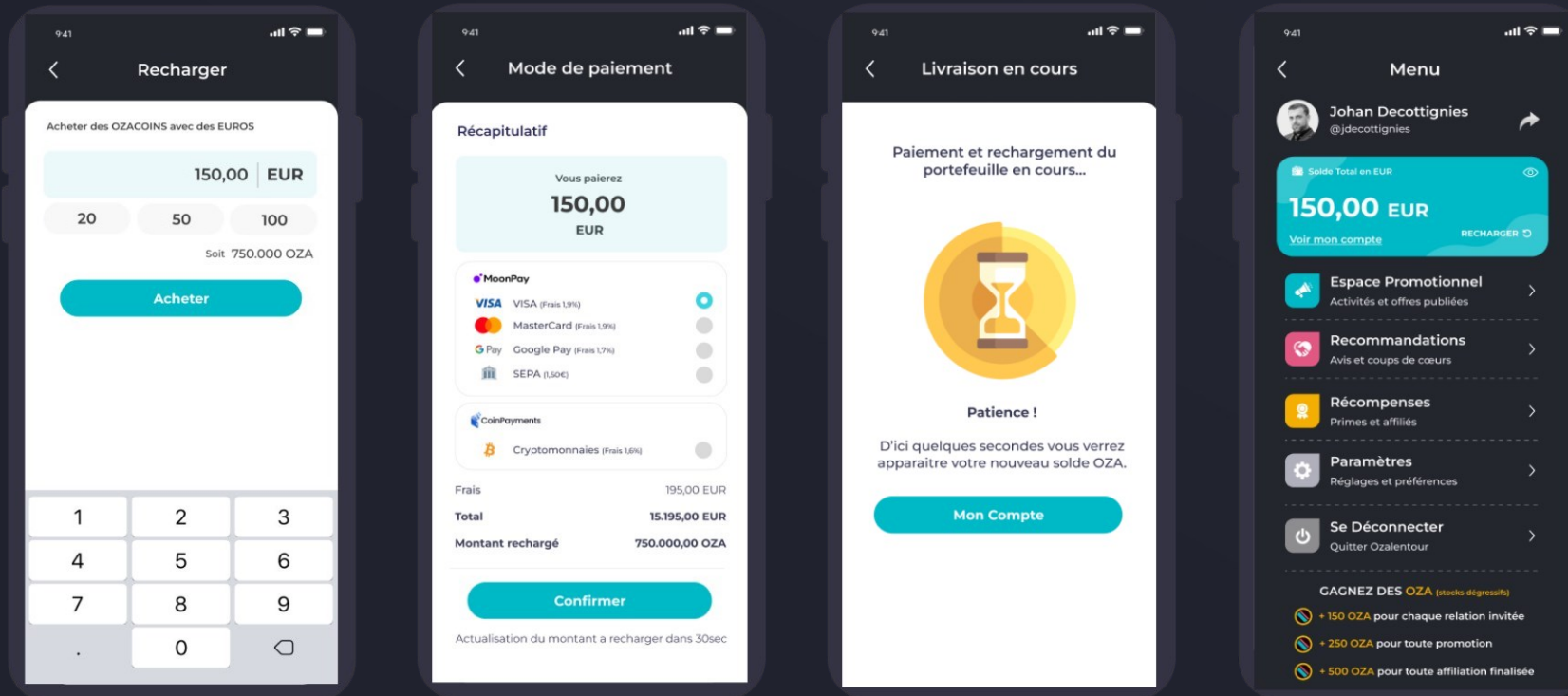
How the OZAPAY account works

EMI regulation: LinkCy SAS, Paynovate agent (Belgian EMI), registered in France under identifier 852295732.

PSAN regulation: LinkCy SAS, PSAN agent, registered in France under identifier E2023-73 (AMF).

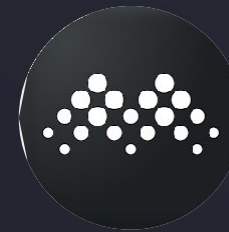
